## Responsibilities

Accepta Ltd. is required to inform any business supplied with these products that **they may have duties in relation to reportable substances** under the Poisons Act of 1972 (as amended).

Our understanding is that any Accepta customer receiving the reportable products listed above must:

- Inform downstream users or customers that these products contain reportable substances
- Report any suspicious transactions or attempted transactions for these products within 24 hours
- Report any significant disappearances or thefts of these products within 24 hours
- Ensure their staff are sufficiently trained and aware of any obligations or requirements

This list is not exhaustive, and customers should consult government guidance to ensure that they are aware of all of their legal obligations. We would also recommend that all hazardous and reportable products are stored safely and securely and checked regularly.
